The "village decides" aimed at investing resources. Also, it played a big role in activating the local society to accept it, which was reflected through:

- 1. The Fantastic way that Dalia followed to activate and involve the local society by delivering invitations (schools, mosques, institutions, workers whether males or females).
- 2. Distributing the grant honestly without bias. In other words the local society distributed the grants to the institutions depending on their roles and effectiveness in the local society.
- 3. The way of choosing the monitoring committee: it was at the absolute desire of the members of the institutions. Besides, Dalia guidance and follow up for this committee was distinguished and admirable.
- 4. The absolute transparency and honesty of Dalia Association is obvious. Therefore, Dalia was interested in involving the local society in monitoring the bills.

The drawbacks of the institutions from the monitoring committee point of view:

- 1. **Al-Zawya Women's Association**: The studio is not air-conditioned; weak advertising; delay in repairing the camera.
- 2. **Abdulqader Abu Naba'a Cultural Center**: the center is full of things because they do not have a store. The municipality promised to build a store, but they haven't built it yet.
- 3. Youth Leadership Club: Sanitation units are not available until now, because the building is in progress.
